

# Pine Nursery Pickleball Courts Information for Events

This information sheet is intended to provide you with details about the pickleball courts and surrounding park area. The *Athletic Facility Rentals Info and Guidelines* has additional information regarding the reservation process and other requirements for your rental.

#### **PARK AVAILABILITY**

The rental season is April 1 – October 31.

#### **EVENTS PER YEAR**

Maximum of 2 tournaments per month. A single tournament may not exceed 2 days.

#### **CAPACITY**

- There are 16 courts available.
- Capacity is dependent on tournament features, layout, activities, traffic flow and other activities scheduled at the park.
- Recommended capacity: 150 (includes participants, spectators, etc.)

# **PARKING/VEHICLES**

- There are 117 parking spaces adjacent to the courts with plenty of additional parking nearby.
   Parking is shared by public park goers including off-leash dog park users.
- Vendors and attendees need to be informed as to allowable parking.
- Tournament organizers will be asked to develop a parking plan as a component of their logistics plan.

#### **AMPLIFIED SOUND AND NOISE**

Use of amplified sound and noise limitations are defined in Deschutes County code (Chapter 8.08).

#### **AMENITIES**

- 4 fixed garbage cans are located around the courts
- 2 portable restrooms are located adjacent to the courts on the east side
- Water fountains located just north of the courts next to the shade structure
- Shade structures are located on the north side of courts 9-16
- 8 fixed picnic tables are located just south of the courts

### **ADA**

The American's with Disability Act (ADA) is a federal civil rights law that prohibits discrimination against people with disabilities and opens doors for full participation in all aspects of everyday life. BPRD will provide guidelines that are intended to help event organizers design events to accommodate people of all abilities. This information is not intended to be an all-inclusive guide to ADA compliance. It is the responsibility of the event organizer to understand and comply with all federal regulations that pertain to the Americans with Disabilities Act.

# **SET UP/TAKE DOWN**

Set up and start time will be determined at the pre-event meeting with the district event team. The event organizer needs to be present for set up and take down.

#### **ANIMALS AT EVENTS**

Dogs are not allowed on district tennis or pickleball courts. Dogs must be leashed in all district parks and facilities except in designated off-leash areas. Tournament organizers may prohibit individuals from bringing animals into an area where a special event is being held. This prohibition does not apply to service animals.

#### OTHER CONSIDERATIONS

- A limit of two food truck vendors allowed in designated area
- Electricity is available onsite, water is not
- Additional garbage cans and porta-potties are required by event organizer
- \$2 mil Insurance is required for all athletic facility rentals
- Open fires and charcoal barbecues are prohibited

Any variance from these park use conditions must be pre-approved by the Bend Park and Recreation District.
