Least Favorite Features

- By far, the main dislike was the size of the parking area and/or that we are adding new parking.
 Many respondents specifically noted that they just don't like change.
- The next highest ranking, especially for Options B & C, was lack of access (ADA, boat, emergency, drop-off, etc).
- Most people greatly disliked the location of future parking in Option A. Most disliked the square design of the parking area in Option A as well.
- People are concerned about the impact the upgrades will have on the wildlife and habitat.
- There were several one-off suggestions on modification to individual features, but no other significant themes emerged.

Feature Incorporation

- Minimizing impact to wildlife and preserving the natural character of the park to the extent possible is popular across all options.
- People are very split on vehicle access into the park. Some see it as a priority to get ADA access close to the river. Several people commented on needing access to drop of gear (kayaks in

particular). Others extremely dislike how the road cuts into the park and divides the open space. These folks generally prefer to keep all vehicles close to the road or eliminate parking entirely.

- People are split on the meandering 3% trail in Option C. Some really like it for the experience, others really dislike it and want a more direct path of travel.
- People really like the overlook in Option B.
- More bike parking in multiple locations is desired in all options.
- It was not a large response, but a few people specifically commented on liking the addition of the southern crosswalk in Option C and the bus pullout in Option A.
